Homelessness Study Updates



In our most recent issue of *Housing with a Heart*, I shared statistics from the annual "State of Homelessness Study: 2022 Edition" by the National Alliance to End Homelessness. I noted that in the study results, the data was not entirely up to date due to restrictions in data collection caused by COVID and at the time, the study still reflected data from 2022.


In mid-December, HUD released its "2022 Annual Homeless Assessment Report" which contains more up-to-date information. While the overall number of people experiencing homelessness in 2022 increased slightly compared with 2020, it rose significantly for individuals, people with disabilities who experience long-term homelessness, and people in unsheltered settings. Here are some highlights and comparisons including direct quotes from the HUD Report.

- The report from 2020 gave a single night's "point in time" homelessness count of 580,466 people, while the 2022 HUD data reported 582,462. The study said there was only a 0.3% increase in the number of people experiencing homelessness from 2020 to 2022, and stated the increase could have been much more because of COVID-19, but was successfully curbed due to investments in homeless assistance through the American Rescue Plan, partnerships, and government agency outreach.
- Though seniors were not a specific data point in the point-intime snapshot, the estimates of homelessness in homeless shelters indicates an increase in recent years of older homeless persons.
- Single individuals not part of family households continue to represent the largest group (72%) of people experiencing homelessness and increased by 3.1% over the two years.
- The number of families with children experiencing homelessness declined by 6% between 2020 and 2022.
- Veterans made up 6.8% (33,129) of people experiencing homelessness and of those, almost all veterans were experiencing homelessness as individuals rather than as part of a family.

I cannot help but think of our former Chairman Emeritus Morton Bahr when I review these updates! I know Mr. Bahr would be proud that we work to increase awareness of the disquieting plight of the homeless every year with "Morton Bahr Homeless Awareness Day." Every year on Mr. Bahr's birthday, July 18, our communities across the country hold drives to collect food and supplies to help local shelters and organizations who support the homeless.

It is critical that EHDOC continues to advocate for additional government dollars for rehabilitation of existing affordable housing communities and for financial support of development for new communities (see our cover article on Page 4.) The more housing we can provide, the more options the homeless and low-income elderly will have, and the more smiles we will see on our residents' faces. Our seniors deserve our commitment to affordable quality housing!

Preservation vs. New Construction

Both Vital to Preserving & Expanding Affordable Housing for Seniors




America's multifamily affordable housing stock for "extremely low, to low-to-moderate income seniors"— those who earn up to 60% of the area median income (AMI)—is slowly but surely disappearing because of the lack of focus on preservation. The often overlooked multifamily properties that provide decent, safe, affordable homes with on-site supportive services for millions of seniors that exists in all parts of the country are an essential element of our national infrastructure and the fabric of our local communities. The continued loss of this critical and underappreciated real estate asset class will impose an even greater social and economic cost on our country in the years ahead if we don't focus on preservation now.

EHDOC believes "preserving" the nation's existing housing for lower income seniors, ensuring that it remains in good physical condition, safe, secure and affordable to households that are most vulnerable that need it, must be a top priority for the real estate community, public officials, the federal government, and the nation as a whole. The combination of conventional real estate economics and prevailing political realities requires new models and a new approach to meet this challenge. Recent years have seen new approaches emerge for preserving multifamily affordable senior housing and, in some cases, for building new affordable units. Those approaches led by nonprofit organizations, such as EHDOC, are demonstrating that in fact a market opportunity exists in at least partly meeting this particularly pressing and growing need.

Investing in the existing housing infrastructure for lowerincome seniors is in fact a much higher yielding financial and social investment for the country than building new apartment units for this group: preservation costs 30-50 percent less than developing new constructed units, according to the U.S. Department of Housing and Urban Development. Preservation can also contribute to community stability and can result in a more environmentally sustainable and cost effective use of resources. New construction does create hope and adds to the inventory, and often serves as anchors of community revitalization where such opportunities may not have seemed possible in the past. However, affordable housing preservation is equally as important as new construction and is essential to meeting a community's affordable rental housing needs.

EHDOC works tirelessly and continuously on ways to expand the affordable housing inventory for frail and disabled low-income seniors by researching new construction opportunities. At the same time it places equal focus on preserving its precious aging assets across the country, DC and Puerto Rico. Under EHDOC's new leadership, Melanie Ribeiro, President and CEO Roland Broussard Vice President

G THE FUNDS:

In October 2022, the US Government Accountability Office published its report on "Special Fiscal Year 2022 Provisions for the Department of Housing and Urban Development".

The **Consolidated Appropriations Act**, 2022 earmarked approximately \$1.5 billion to HUD for 1,014 projects at the request of Members of Congress.

The \$1.5 billion will support a variety of economic and community development

efforts, including preventing homelessness, expanding the supply of affordable housing, and improving local infrastructure.

The following excerpts are from a LeadingAge article by Linda Couch, "Review of FY23 HUD Bill: Affordable Senior Housing" which provides a detailed summary of the bill's impact on affordable senior housing.

The **Omnibus bill** provides \$110 million for new capital advances and Project Rental Assistance Contracts for new Section 202 homes. The new funds for FY23 are expected to result in about 1,120 new Section 202 homes. Of the \$110 million, \$25 million is set aside for intergenerational households.

The bill includes \$50 million for about 12,000 new Housing Choice Vouchers. It would also fully fund grant-funded

The bill also includes a new \$85 million program to incentivize local governments to improve zoning practices for affordable housing and a new \$75 million program for new Permanent Supportive Housing to expand housing options for people experiencing homelessness.

The omnibus bill provides full funding to renew Section 202 Project Rental Assistance Contracts, increasing the Section 202 account by \$42 million to \$1.075 billion. Also, full funding of Section 8 Project-Based Rental Assistance contracts means an increase to this account by \$1 billion to \$14.9 billion.

On December 19, 2022, the Biden Administration's US Interagency Council on Homelessness released a plan to end homelessness.

Entitled "All In: The Federal Strategic Plan to Prevent and End Homelessness," the 104 page plan notes "...the United States suffers from a severe shortage of safe, affordable and accessible

rental housing." The plan is based on six pillars: three foundations – equity, data and evidence, and collaboration, and three solutions – housing and support, crisis response, and prevention. The plan enrolls 19 federal agencies in a multi-year roadmap to reduce overall homelessness by 25% by 2025.

EHDOC's Celena Regan Receives National Recognition



Meet AASC's 2022 Service Coordinator of the Year Award Winner!

We couldn't be more excited and proud of our own Celena Regan, who has been recognized as the American Association of Service Coordinators' 2022 Service Coordinator of the Year! Celena is Service Coordinator of our Louisiana communities Point Villa, Morse Manor and Leisure Lane, where she has made residents happy since September of 2017.

The 23rd Annual American Association of Service Coordinators (AASC) Awards were held online on December 15, 2022. There were 357 nominations for the Service Coordinator of the Year award, pouring in from 48 states. According to the organization, the award honors the Service Coordinator for innovative programs, outstanding achievements and contributions made toward the profession to keep residents healthy, happy and at home.

Celena cited one of her favorite quotes to describe how blessed she feels about her role at EHDOC as Service Coordinator, stating: "If you love what you do, you'll never work a day in your life."

Celena began her career in Human Resources, then transitioned to Service Coordination. She loves working one-on-one with seniors and says it is a privilege to serve them with support that keeps them living independently in their homes. She noted that the most impactful thing that Service Coordinators do is act as advocates for seniors. "We are their voices," she said.

One of the things that Celena is most proud of in her career, is presenting a statement about the long waiting list in the Choice Waiver Program to the Louisiana Housing Appropriations Committee at the Louisiana Capitol. She provided testimony to give her residents a voice. The outcome? 500 new slots were added to the waiver list!

When asked what motivates her daily, Celena said, "It is the winning days." There may be days that present a challenge, but there are days when things work out for her seniors for good, and those days are the most rewarding.

Celena provides Service Coordination services for four properties in rural small villages of Louisiana. To EHDOC, Celena's positive impact on our seniors and the Service Coordinator profession is anything but small. We are proud of our national award winner – well deserved, Celena!




